SUBJECT: Policy Memorandum for On-The-Spot (OTS) Cash Awards

Reference Army Regulation 672-20, Incentive Awards, dated June 1, 1993.

The above reference, currently under review, authorizes OTS cash awards in amounts ranging from \$25 to \$250. Once we have completed the review of the regulation, the criteria in AR 672-20, paragraph 4-4, will change to increase OTS cash awards to amounts ranging from \$50 to \$500. Until the new range is formally incorporated into the regulation, the range of \$50 to \$500 applies throughout Army and is effective immediately.
